ACT TO AMEND THE JUDICATURE ACT, NO. 2 OF 1978

Section 45 of the Judicature Act, No. 2 of 1978 (herereferred to as the "principal enactment") is hereby led by the insertion, immediately after subsection that section, of the following new subsection :---

a) The Minister may by regulation specify the ers (whether holding office permanently or tempoy) who shall be *ex officio* Justices of the Peace for Republic of Sri Lanka or for any portion thereof, ectively, as is indicated in such regulation.".
